

- If there aren't any boosts in housing aid, there will be 4 million very low-income senior households by 2030 who will be left to find affordable and safe housing in the private market.
- Today, more than 900,000 low-income families use public housing (Fischer, 2021). This number will likely increase as wages decline and more people require affordable housing.
- Inspections of public housing, rental assistance program, and other subsidized properties is mandated.
- Initial move in inspections is completed to ensure the habitability of the unit.
- Occupied public housing and multifamily housing properties are inspected every 1 to 3 years. Special inspection such and complaint, move out and rent reasonableness are completed by the PHA inspection team on an as needed basis.
